5. Immigration Laws and the Faithfully Execute Clause of Article II of the Constitution.
6. Open Borders and the 10<sup>th</sup> Amendment to the Constitution.
7. Sealed Oaths and Affirmations in Support of Warrants, Warrantless Wiretapping, National ID Cards, Un-verifiable Voting, RFID Chips and the 4<sup>th</sup> Amendment to the Constitution.
8. The Absence Of Organized State Militias and the 2<sup>nd</sup> Amendment to the Constitution.
9. Gun Registration and Gun Permit Laws and the 2<sup>nd</sup> Amendment to the Constitution.
10. The Absence of Cameras In The Courtroom and the 6<sup>th</sup> Amendment to the Constitution.
11. The North American Union and the Treaty Clause of the Constitution.
