SUMMIT IN PHILADELPHIA

Group Seeks Productive Change And Strength In Numbers Based On Old Model



Everywhere one looks today, there seems to be corruption, legislation passed violating the Rights of the People, and constitutionally questionable decisions by judges that have many Americans angered. Adding to that anger is uncertainty about how the People can effectively stop these abuses.

Robert “Bob” Schulz, Chairman of the We The People Foundation For Constitutional Education, www.wethepeoplefoundation.org, is organizing an historic People’s summit in Philadelphia intending to mirror the assemblies once conducted by America’s founding fathers. He maintains it is a formula that worked before and sees no reason why it can’t work again.

“When this country’s founding fathers first met in Philadelphia in the late 1700’s, they were not seeking to secede from Great Britain,” he says. “On the contrary, they simply wanted their government to listen to them and honor their natural Rights – including the Right to a government that protects their inherent Liberties and the Rule of Law. Today, many Americans know our government has stepped far outside its authorized boundaries but don’t know what they can do to stop it.”

The problem, as Schulz sees it, is that people who feel this way aren’t speaking with one collective voice and they remain largely unfocused about the root problems and viable solutions that could curtail the abuses. He sees the People’s summit as the first big step in changing that.

Schulz envisions three delegates from each state attending the summit who will, in total, represent 15 million Liberty-minded citizens. He also wants to emphasize that he is not seeking to exclude any currently elected officials. “Again, contrary to what one might think,” says Schulz, “we are inviting three state legislators from every state as well so that they can understand the People’s Grievances, become aware of the curative process, and appreciate the relevance of the proceedings as they may relate to the states.”

Bob Schulz has an engineering degree from the United States Merchant Marine Academy (1963), and a Masters Degree in Business Administration from Xavier University (1969). He completed most of the course work for a Ph. D. in Public Administration at the Graduate School of Public Affairs, State University of NY.

Bob has held significant positions in industry (General Electric), in government (Connecticut, New York State, and the U.S. Environmental Protection Agency), on Wall Street (Prudential-Bache), in business (founder and CEO of a consulting firm), and on the radio as a talk-show host (with WROW in Albany, New York).

Bob received an honorable discharge from the U.S. Air Force in 1959 and he answered his country's call by volunteering as a ship's engineer during the sea-lift to Vietnam in 1966.

However, this work and these assignments are not Bob's principal reason for being.

Although he is not an attorney, he is not unskilled in the law. For the past 29 years Bob has been occupied with an abiding concern about wrongful governmental behavior and has been carefully evaluating governmental behavior, comparing that behavior with the requirements of the State and Federal Constitutions and unhesitatingly confronting improprieties and conflicts, in the courts, professionally, intelligently and rationally.

Bob has performed the research, prepared the briefs and argued cases in the highest state and federal courts. At least one hundred fifty five (155) decisions have been rendered in cases he has brought against unconstitutional and illegal governmental behavior, often with other citizen-plaintiffs.

Be assured, Bob is not some legal crank, interested in making a reputation. The things he has been dealing with are painful to him and costly. He has done much of this on his own, but he has received the encouragement and support and participation of a growing number of people throughout the country.

Bob and his wife, Judy, of 45 years live on a small farm on the east side of Lake George, NY, where they raised four children, each of whom has graduated from one of America's finest universities.
