# **EVENT SPACE**

#### **Grand Hall Overlook**

The Grand Hall Overlook is truly a grand and enchanting space, providing a spectacular view of Independence Hall through a wall of glass 40 feet high. Located on the National Constitution Center's second floor, the unique 13,000 square foot space inspires creativity in any event. Guest access is provided via the Grand Hall Staircase from the Main Lobby or elevators are also easily accessible to accommodate all of your guests needs.

National Constitution Center reserves the right to require the program to end by 4:00pm on days that the museum has an event booked in the evening. The National Constitution Center will notify the client of these dates, but reserves the right to continue to book evening events as necessary.
